Subject: Malt Beverage Licenses Eligible for Video Lottery

Ordinance 3210, approved by the City Council in July of 1995, requires that the Council review the number of malt beverage licenses eligible for video lottery at the second meeting in July of each year.

According to the information submitted by the Planning Department, the City's estimated population is 60,466. Ordinance 3210 allows one license for each 843 in population. As a result, the City is eligible for 71.73 licenses. As of July 1, 2000, there are currently 71 licenses issued, therefore no additional license will be available.

RE: Rapid City 1999 Population Estimates

Each year the Planning Staff prepares a population estimate for the previous year. As you may recall, the Planning Staff has expressed concerns since 1995 that even the most conservative methodology utilized will "over estimate" the actual population count.

The 1999 estimates were derived using the U.S. Census Bureau's Subcounty Population Estimates Methodology. This method takes into account a 7.24 month lag time between the issuance of a building permit and the completion of construction, a factor of .98 to estimate the completion of new units, the estimated number of mobile home placements, and the estimated number of housing unit losses. After researching numerous professionally accepted methods, this methodology was chosen as communities can use this method to challenge U.S. Census Bureau estimates. As has been expressed previously, staff remains concerned that these estimates will exceed actual population counts in the 2000 Census; however, we believe the methodology utilized here represents the most accurate estimate possible.

Staff Recommendation: Approval of the 1999 Rapid City Population Estimate of 60,466.
