4. Agency shall not file any legal action on any account without prior written approval from Client, as set forth in a signed and dated assignment.
5. Client agrees to promptly acknowledge to Agency any payments made to Client or his authorized representative on all accounts assigned to Agency.
6. Agency agrees to defend, indemnify and hold Client harmless from and against any damages, suits, or actions arising from the negligent, reckless or willful acts of misconduct by Agency, or its Agents, in attempting to collect any just and legal debt under this agreement.
7. This agreement may be terminated by either party upon written notice of intent to terminate.

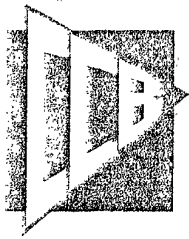

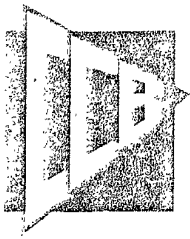
