BE IT RESOLVED by the City of Rapid City as follows:

The City Council hereby declares the necessity of paving approximately 575 lineal feet of alley as located on in Block 13 of the West Boulevard Addition

The general nature of the project is set forth above, and reference for detail is hereby made to the drawings and specifications that will be prepared by the Engineering Department and placed on file with the City Finance Officer.

The estimated costs of the project are \$26,000 which 60% (\$17,000) will be assessed to the benefiting properties on the basis of equal benefit excepting Lot 6 (911 Franklin Street) and Lot 7-8 (915 Franklin Street) which will be assessed a flat rate of \$393.41 and \$786.83 respectively.

These estimated assessed costs include six percent (6%) engineering fees and five percent (5%) fiscal fees. Interim construction fees to be determined by the Finance Officer shall be included in the project cost, which will be assessed to the benefiting properties.
