
Attached please find exhibits showing Knollwood Drainage Basin Elements and the parcel proposed to be purchased. The lands to be purchased would provide the City needed land to construct open channel drainage necessary for the entire Knollwood Drainage Basin. Upon completion of the drainage channel, through the present Railroad Lands, the City may elect to sell the remainder of the property.

Project DR 04-1390 as outlined in the Kollwood Drainage Basin Design Plan (DBDP) is the first phase of a drainage reconstruction project for the Knollwood Drainage Basin. Elements 2 & 20 recommend an open channel that will traverse across, what is presently, South Dakota State Railroad property. The State would not allow the City an easement for an open channel drainage, therefore, the Council voted (9-06-05) to lease the land thus giving the City the first right to purchase. Subsequently the SDDOT Railroad Authority has offered the property for sale to the City. Council authorized a survey and platting of the property and such has been completed. Approval for purchase by the City will initiate the title transfer and the ability for the City to proceed with the Knollwood Elements 2 & 20 completion in 2008, Knollwood Element 3 completion in 2009 and Knollwood Element 5 completion in 2010.

The existing drainage facilities in Elements 5 and 3 are extremely undersized and presently causing flooding of Eagle By-Rite property and property just north of Centre Street.


Drainage problem correction must start at Rapid Creek and this purchase will allow these corrections to be implemented.

Funds have been budgeted, \$750,000.00, out of fund 8911 (Drainage) for the purchase of said property. The City should be able to recover nearly 100% of the cost of this property from the remaining lands once the channel is constructed.

The SDDOT hereby offers for sale to the City of Rapid City a parcel of property east of Cambell Street which includes 4.9987 acres, more or less, for the appraised value of \$490,000. The SDDOT will retain the 100 foot operating rail property.

The legal description of the parcel to be sold is: Tract A located in Section 5, T1N, R8E, B.H.M., Rapid City, Pennington County, South Dakota, formerly Lots 2 (less Lot H1), 4 and 7, of the SW1/4, of the NW1/4, Section 5, T1N, R8E, B.H.M.

If the City of Rapid City wishes to purchase this parcel, please forward a check in the amount of the appraised value of \$490,000 to this office. Upon receipt of the check from the City of Rapid City, we will prepare the necessary Quitclaim Deed and sign the plat.
