Dear Jim,

As requested, enclosed are the recommendations for the City Subsidy awards for 2009, as determined by our committee. As the chart indicates, five of the seventeen applications received this year are mandated by City statute or agreement. Providing the full level of funding for these five organizations would require \$132,000, well above the amount available, and would not leave any monies available for other arts organizations. As shown in the chart, fully funding all approved recommendations, agreements and statutes would require \$175,000. This does not take into account all application requests received in the current year, which totaled \$201,000.

With the current economic climate, we realize that future budgeting choices will be difficult. Given these circumstances, Allied Arts understands that a significant increase in the City Subsidy for 2010 may not be realistic. However, we recommend that the City consider gradually increasing the subsidy over the next several years, to a level that will provide for the full funding of agreements and statues, as well as awards available for other arts organizations.
