RE: Assessment Roll Block 110 Original Townsite Sanitary Sewer Extension East Boulevard Area (Kansas City St. to Quincy St.) Project # SS08-1752 / CIP No. 50742

Submitted herewith is the Assessment Role for costs associated with the above referenced project.

I recommend that \$54,125.74 be accepted as the final construction cost of this project, and that a total cost of \$18,096.72 be assessed to the property owners. The costs to be assessed include net construction costs of \$16,237.72 (70% of construction costs were paid by the City through the Common Service Line Replacement Matching Fund), six percent (6%) engineering fees (\$974.25), five percent (5%) fiscal fees (\$811.88), and construction interim finance charges of \$72.87. Benefiting equally, the assessment to each of the four (4) parcels is \$4,524.18.
