The Rapid City Landfill and MRF are advertising for a new compost screen for use in preparing finished grades of yardwaste and co-compost. The existing smaller trommel screen is no longer effective in processing the volumes of our 3/8" compost necessary to satisfy seasonal demands and the existing electrical trommel screen has becoming unreliable, requiring a significant amount of maintenance to maintain operation.

The proposed replacement unit will utilize a different method for screening. The star screen principle will allow for the changing of compost sizes with the touch of a button, versus a two day/two man process to change screens on the existing electrical trommel screen. The new unit, if approved, will be a diesel/electric model offering energy efficient operation and the ability to relocate around the facility as needed. In addition, the star screen will allow staff to operate with higher moisture composts, creating an environment where year round uninterrupted operation is available.

The solid waste staff recommends this type unit be approved to replace the existing trommel screens.
