Dear Community Planning and Development Services:

This letter is to inform you of my frustration surrounding the possibility of removing a valued and long-standing business from the downtown district. As a native of Rapid City, I remember what an eyesore the 900 block of downtown Rapid City has traditionally been. The transformation of the block, in large part due to Paws Pet Bakery & Mt. Rushmore Birds, has brought diversity and monies to not only the 900 block, but also other shops in the downtown district.

I choose to spend my dollars in Rapid City due to the services provided at Paws Pet Bakery & Mt. Rushmore Birds. I could drive to Casper, WY or even Denver, CO for supplies related to my companion African Grey Parrot, however the bird specialty shops in Casper and Denver are nowhere near the quality, cleanliness, and professionalism found at Paws Pet Bakery & Mt. Rushmore Birds. On a typical trip to Rapid City, my family and I not only spend a significant amount of money at Paws, but also often stay at the Adoba Eco Hotel, shop at other businesses in Rapid City, and eat at area restaurants, both downtown and within the greater city.

If Paws Pet Bakery & Mt. Rushmore Birds, were no longer allowed to operate in its current location, customers from Nebraska, South Dakota, and Wyoming would be forced drive to other cities to spend our dollars. Paws Pet Bakery & Mt. Rushmore Birds is *the reason* why I come to Rapid City to shop on a monthly basis. The shop is not a "pet shop", but an aviary, retail establishment, and education center for individuals who live with companion birds. I cannot understand why the Community Planning and Development Services is being so short sighted regarding this issue. Why would a business that has operated in downtown Rapid City for the past seven years suddenly be closed? Would the city prefer to bring back the filthy adult "entertainment" store that use to occupy the location? If diversity in the downtown district is eliminated, starting with the removal of Paws Pet Bakery & Mt. Rushmore Birds, then I have no reason to shop in Rapid City. This would adversely affect thousands of companion pet owners and the economy of Rapid City.

To the Members of the Rapid City Planning Commission and The Rapid City Council:

We have operated Mt Rushmore Birds in the downtown core since 2007. As a specialty bird store we are currently located at 910 Main St which is our third downtown location. We are certified Avian Specialists selling and caring for exotic companion birds. We do not sell other animals or pets. We sell bird food, toys, cages and supplies plus we provide bird boarding and grooming services. We have a 'rescue – rehome program' with many of those birds coming to us from the Black Hills Humane Society as they are not capable of properly caring for exotic companion birds. We continue to provide long term care for several relinquished birds which are not able to be placed in new homes. We are annually licensed and inspected by the State of South Dakota. We have also paid for an annual kennel license from the Black Hills Humane Society.

Our customers are from South Dakota, North Dakota, Nebraska, Wyoming and Montana. Last summer we even served a customer who lives in Dubai. Some of our out of town customers make a week-end of it when they travel to shop in our store.

At the March 6 Planning Commission meeting, Vicki Fisher of Community Planning & Development Services explained that while we have been a downtown business for 7 years without any complaints, it was recently determined that we are not in compliance with the ordinance governing businesses permitted in the downtown core. No one seems to know why this has only recently become an issue but now the objective is for us to be able to remain a downtown Rapid City business and continue our active involvement with Destination Rapid City. Vicki intends to present an ordinance amendment for consideration at the April 24<sup>th</sup> Planning Commission meeting and the May 5<sup>th</sup> Council Meeting.

We would like to invite you to visit our store prior to that meeting so that you can personally have a look at our business. We will be happy to answer any questions you might have. We are open Monday through Saturday from 10 AM to 5 PM. (Parking is usually challenging during the lunch rush as several of our neighbors are restaurants.)

We thank you very much for your consideration of our continued efforts to remain an asset in the downtown Rapid City business community.

It is my understanding that the Planning Commission is asking Paws Pet Supply Store to relocate somewhere other than downtown where they have been for years. I wanted to tell you a little story about how Barb Paur has positively, albeit inadvertently, benefited Rapid City.

In 2004 my father was in the Rapid City Regional Hospital Hospice House. I would spend the nights with him, and then go down to Paws for a little bird therapy. Because of the time I spent there, I ended falling in love with, and adopting, a little Goffin's Cockatoo named Taupe. As I have an obsessive personality, I then set out to learn everything possible about parrots. Barb Paur was a remarkable resource for me.

In 2010 I had the amazing good fortune of going to work for Best Friends Animal Society as manager of their parrot department. Best Friends is the 3rd largest Animal Welfare group in the country, and has the largest No-Kill sanctuary in the world. This wouldn't have been possible without the knowledge and skill I learned from Barb.

Last May I was doing an "immersion day" (a day when we work in another department) at the Development Office. One of the tasks we had to complete that day was to find rescues and shelters that could benefit from, and had room for, semi-truck loads of Blue Buffalo Dog Food. I called the Black Hills Humane Society in Rapid City, and they were thrilled to take possession of an entire semi-load.

Because of Barb and her birds I went to work at Best Friends. Because I work for Best Friends I was able to supply a truck load of dog food to the Rapid City shelter, which ended up saving the city a good chunk of money.

I am a property owner in Rapid City, and I am in the process of moving back to the state. I fully intend to support Barb Paur and her wonderful store. Barb has been an amazing community asset for many, many years and deserves respect for the work she has done.

I'm writing to you today in regards to the Paws Pet Bakery & Mt. Rushmore Birds. There has been a concern from the shop that they might be forced to close or relocate due to some ordinance or law that states a "pet shop" may not be located in the downtown core.

I feel that such an arbitrary idea does not serve our city well. Paws has been a station of aviary excellence that performs a unique need in our city for more than 7 years now. Bird owners from far and wide visit to get their companions groomed and taken care of. The store, which has been in its present location for almost a year now, also serves the city: Many rescue birds have been taken into the store when the city doesn't have the expertise or resources to take care of the birds it receives.

The store is immaculate and very inviting. We attend the dog show at the Civic Center as do many of my friends. Walking to downtown is a quick break from the show and being able to shop at a locally owned shop within a reasonable walking distance is a highlight of the weekend. If we forget any supplies they have it. I feel downtown areas should be diverse, offering something to everyone in the community and beyond and this store is a delight.

Years ago we spoke with a gentleman who owned a business downtown that sold Irish and Scottish goods. It was a fun shop but the last time we were there the man told us the planning commission was out of control and wanted to shut down any business that did not fit into their master plan. At the time I thought he was silly and paranoid but now I see he might have been correct.

Please consider the people that shop downtown in your decision and do not make the mistake of writing off a small locally owned business. Paws Pet Bakery draws people from all over the country. We come from Colorado and we thoroughly enjoy the store. I have a friend from Nebraska that buys her bird supplies and birds there when she comes for the show and then shops the remaining stores in the area. This small shop has local flavor and is quite unlike Petco or PetsMart or any of the national pet supply stores.

I would hate for your downtown to become another generic downtown. What you have now is special and interesting and one of the reasons we drive to Rapid City for the shows.

Members of the Commission:

I learned with great distress of the possible action that would cause Barb Paur to cease business at Paws because , as I understand it, the city does not want a pet store in the city center.

I am confused by this for many reasons: first Paws operated for a number of years in a very prominent downtown location - almost at the corner of St. Joseph and 6th streets - and it was never more than a spotlessly clean, visually attractive place of business. The new location of Paws is presenting the same image - clean, attractive and engaging.

Additionally, I would hope the Planning Commission is pleased and supportive of the efforts to move reputable, locally-owned businesses into the area where Bully's, the art gallery and Paws have located. Are those not attractions that would appeal to area visitors?

There are any number of locations in town that truly fit 'a pet store' in the sense that a variety of animals and reptiles can be purchased there - namely the Humane Society, Pet Smart and Pet Co and possibly some in other venues.

Paws does none of that and unless given strong argument and examples to the contrary, I would suggest and hope that the Commission will revisit their position and allow Paws to remain as a contributing part of the community.

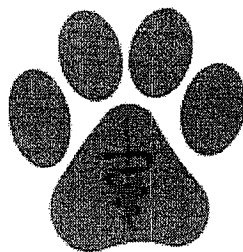

If an anonymous donor steps in and pays the \$300 fees, and it is suddenly legal, does not that stink of extortion? Mayor Kooiker, we voted for you to clean up City Hall. This harks back to the days of citizens jumping through hoops to get something done!

Converting a decrepit porn theatre into a set of bright charming shops was a million-dollar undertaking, and the City knew exactly what was going in there. Forcing a senior business woman to go through all this bureaucratic nonsense is shameful behavior. If the City now thinks it's illegal, then too bad. Overlook it. Correct the ordinance, not the business. Move on to something more productive. Seriously.


