ADDENDUM TO RAPID CITY AREA 2006 UNIFIED PLANNING WORK PROGRAM AGREEMENT

WHEREAS, on December 1, 2005, the Rapid City Area Metropolitan Planning Organization approved the Final 2006 Unified Planning Work Program (UPWP); and

WHEREAS, on December 19, 2005, in compliance with the federal requirements for a metropolitan planning organization to utilize federal transportation planning funds, the City of Rapid City approved the Final 2006 Unified Planning Work Program; and

WHEREAS, on December 19, 2005, the City of Rapid City approved entering into an agreement with the South Dakota Department of Transportation in order to carry out the activities identified in the 2006 Unified Planning Work Program to accomplish the Rapid City Area Transportation Planning Process for the purpose of providing partial funding for the metropolitan area study activities; and

WHEREAS, the South Dakota Department of Transportation and the City of Rapid City entered into various yearly agreements to accomplish the Rapid City Area Transportation Planning Process for the purpose of providing partial funding for the metropolitan area study activities scheduled as outlined in the Unified Planning Work Program covering 2005; and

NOW THEREFORE the parties agree as follows:

The 2006 Unified Planning Work Program Agreement, as approved, shall be amended to include the funding required for and the completion of the Personnel Services and Professional Services/Consultants Tasks as identified in the 2005 Unified Planning Work Program as follows:
