RE: Historic Preservation Commission Grant
Time Extension of Project Funding

The Historic Preservation Commission requests approval of Amendment #3 to State of South Dakota Historical Preservation Allocation Award for Preservation Project SD-07-21. The Amendment will extend the time allowed to complete the 2007-2008 CLG Grant from the May 30, 2008 deadline to an August 31, 2008 deadline. The requested time extension would allow the funding of educational and promotional materials for the public on a proposed change in the Historic Preservation Ordinance to be completed.

Request: The Rapid City Historic Preservation Commission requests authorization of the Mayor and Finance Office to sign Amendment #3 to State of South Dakota Historical Preservation Allocation Award between State Historical Preservation Office, Office of History and Rapid City Historic Preservation Commission Project SD-07-21 changing the completion date from May 30, 2008 to August 31, 2008.

THIS AMENDMENT, made effective 22 April 2008, by and between the State of South Dakota acting herein through the Office of History, State Historical Preservation Office (hereinafter called the State) and Rapid City Historic Preservation Commission, Rapid City (hereinafter called the Subgrantee) pursuant to the provisions of SDCL 1-19A.

WITNESSTH:

WHEREAS, the State has heretofore awarded an allocation to the Subgrantee to promote historic preservation in Rapid City;
WHEREAS, the Subgrantee has asked for a time extension to complete the projects outlined in the current agreement;
WHEREAS, the State agrees that such a change will be beneficial to the State in terms of receiving a completed product;

NOW, THEREFORE, in consideration of the foregoing and the mutual covenants and agreements herein contained, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree to amend the Allocation Award as follows:

- 1) Change the end date to 31 August 2008.

Except as hereby modified, the aforesaid Allocation Award shall otherwise be in full force and effect and is hereby expressly approved, ratified, and confirmed.
