SUBJECT: 2014 RCPD Vehicle Purchases

This year (2014) the Rapid City Police Department is seeking City Council approval to purchase 4 new SUV Police Interceptors from McKie Ford in Rapid City. The State Bid cost of one SUV Interceptor (with options) is \$28,381; please see the attachment for more information.

McKie Ford in Rapid City is able to match the State bid price and a quote from them is also attached for review. Four vehicles at the State Bid price of \$28,381 totals to \$113,524.

The RCPD applied was recently awarded \$58,000 from the State of South Dakota's Drug Control Fund (see the attached award letter). The \$58,000 from the State Fund is specified for vehicle purchases and this funding will cover the cost of two SUV Interceptors; bringing the **total vehicle purchase expenditure for the RCPD down to \$55,524.**

RE: Award of \$58,000 for 2 Ford Interceptor Utility Vehicles

Dear Assistant Chief Jegeris,

Your letter request of November 18, 2013, requesting \$58,000 from the Drug Control Fund for two Ford Interceptor Utility Vehicles has been approved in the amount of \$58,000. I understand state bid price for each of these vehicles is \$26,076 but you are requesting \$29,000 per vehicle for necessary upgrades. We are in the process of getting a check for you through the state voucher system for that amount.

We are providing these funds to you pursuant to SDCL 34-20B-64, which requires that these funds or assets be used for drug apprehension purposes. Should you not need the \$58,000 for the vehicles, the funds will need to be returned to this office and deposited into the Drug Control Fund. Or should you no longer need the vehicles, you will need to return the vehicles to us where they will be re-utilized. Your Department will have to assume responsibility for the upkeep, insurance and any other related expenses upon the vehicles, until they are returned to us.

In response to Government Operations and Audit Committee (GOAC) comments, once you have utilized the award money as indicated above, you will need to send me the paid invoices and receipts for your purchase within 30 days of the expenditure.

I look forward to continue working with your agency. Please don't hesitate to contact me, Bryan Gortmaker or Bridget Mayer for assistance. Keep up the good work in drug enforcement!
