2	FURNISH 6" COLUMN PIPE	THE PUMP WAS ACTUALLY SET AT 523' INSTEAD OF 492' INCREASING THE BID QUANTITY.
3	FURNISH 4/0 (FLAT) SUBMERSIBLE PUMP CABLE	THE PUMP WAS ACTUALLY SET AT 523' INSTEAD OF 492' INCREASING THE BID QUANTITY.
